Publications: Preparation and distribution of the members-only printed publication, Conifer-Quarterly. Management and maintenance of the Society's website, with information available to the general public. Both publications cover the botany, horticulture, nomenclature, identification, conservation and uses of conifers. The website houses one of the most comprehensive plant databases on the internet.

4b (Code:) (Expenses \$ 23,668 including grants of \$ 23,668) (Revenue \$)

Grants and Scholarships: The Society provides grants to qualifying public and private institutions to extend and enhance conifer collections, support research on conifers and aid in conservation of conifers. The Society also grants annual scholarships to students in horticulture and related fields who are studying various aspects of conifers.

4c (Code:) (Expenses \$ 15,011 including grants of \$) (Revenue \$ 26,532)

The CCOY program offers ACS members an opportunity to purchase rare dwarf and/or full-size cultivars that are shipped directly from the growers each spring. Annually, a committee meets with growers to select unique specimens not normally found in nurseries open to the public. The CCOY program is restricted to active members of the American Conifer Society and is open for a limited time each winter or until the present year's stock sells out. Purchase is limited to one of each selection per member. Proceeds from these sales benefit the ACS and help us further our mission.
